Implementation of special educational methods (such as evening and Saturday/Sunday classes)

Some classes at this Graduate School will be implemented with the special educational methods stipulated in Article 14 of the Standards for the Establishment of Graduate Schools (where consideration is given to the working conditions where an employed person is employed and the time required for commuting to the university, and the class times are set either within normal class hours or at a specific time outside of normal class hours or at a specific period of the year).

1. Admission Policy

The Graduate School of Human Development and Environment aims to produce graduates who 1) contribute to fundamental, applied, and practical research and education activities on human development and supporting environments in a proactive and self-motivated manner and 2) apply their advanced expertise to play a leading role to advance such research and education activities.

The Graduate School achieves these objectives by accepting students according to the policy below.

- Applicants are sought with the following qualities and abilities:
 - 1. The fundamental qualities and abilities necessary to perform advanced research [Required competences: knowledge and technique]
 - 2. The qualities and abilities required to identify new issues based on a keen awareness of and in-depth expertise in the various challenges related to human development and supporting environments [Required competences: knowledge, technique, critical thinking, sound judgement, expression, interest, and motivation]
 - 3. The advanced intellectual ability needed to analyze existing issues in a multilateral and multi-layer manner and to systematically conceptualize and theorize such issues [Required competences: knowledge, technique, critical thinking, sound judgement, expression, initiative, cooperativeness, interest, and motivation]
 - 4. The ability to propose concrete measures in order to solve modern issues and respond flexibly [Required competences: knowledge, technique, critical thinking, sound judgement, expression, initiative, cooperativeness, interest, and motivation]

• Basic Policy for the Selection of Students:

To select students in accordance with the Diploma Policy and Curriculum Policy of the Master's Program of the Graduate School of Human Development and Environment, each applicant's competencies are evaluated. The General entrance examination, Special entrance examination for working adults, and Special entrance examination for international students comprehensively assess knowledge, technique, critical thinking, sound judgement, expression, initiative, cooperativeness, interest, and motivation.

- 1.Of the 51 offers in the admission capacity for the Department of Human Development, the Clinical Psychology Course will offer about 10 places on a course a curriculum that allows students to obtain eligibility to sit the Certified Public Psychologist examination.. It is also necessary to either have completed and graduated from the required undergraduate courses for a Certified Public Psychologist, or else to satisfy the requirements of the special exemption for examination qualification. (Student will not be eligible to obtain eligibility to sit the Certified Clinical Psychologist examination.)
- 2. Applications for admission to the one-year master's program in the Department of Human Development will be accepted separately.
- 3. Applications for the recommendation-based entrance examination for the Department of Human Environmental Science will be accepted separately.

3. Eibility

I. General entrance examination

Applicants must meet at least one of the following criteria.

- (1) Applicants who have graduated or will have graduated from a four-year program in Japan by March 31, 2026.
- (2) Applicants who have received a bachelor's degree under Article 104-7 of the School Education Law of Japan or will have received one by March 31, 2026.
- (3) Applicants who have completed at least 16 years of formal education overseas or will have completed it by March 31, 2026.
- (4) Applicants who have graduated with at least 16 years of formal education at an overseas school by completing the class subjects in a distance learning course while residing in Japan, or will have completed the course by March 31, 2026.
- (5) Applicants who have completed the course at foreign university, or will have completed the course by March 31, 2026 (limited to those courses whose graduates are considered to have completed 16 years of formal education in the foreign country). The school must be recognized as an educational institution by their home country's education system, and approved by the Minister of the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- (6) Applicants who have received a degree equivalent to a bachelor's degree by completing at least 3-year program at a foreign university or other foreign educational institution. The foreign university or other foreign educational institution must be accredited in terms of overall education and research activities by the respective foreign government or a person certified by the appropriate foreign governmental agency, or have been so designated by the Minister of the Japanese Ministry of Education, Culture, Sports, Science and Technology. The above mentioned 'at least 3-year program' can be completed: by taking class subjects offered by the respective foreign educational institutions in distance learning format while residing in Japan, and by graduating from an educational institution which is recognized by the home country's education system and specified in the previous item (5).
- (7) Applicants who have graduated from specialized training colleges course (limited to courses of at least four years of duration and of meeting the other standards specified by the Minister of the Japanese Ministry of Education, Culture, Sports, Science and Technology) that has been separately recognized by the Minister of the Japanese Ministry of Education, Culture, Sports, Science and Technology, or will have graduated from the course by March 31, 2026. The date of graduation must be after that determined by the Minister.
- (8) Applicants who have been specially designated by the Minister of the Japanese Ministry of Education, Culture, Sports, Science and Technology (under the Ministry of Education Notification No. 5, 1953).
- (9) Applicants who have enrolled in Japanese graduate school under Article 102-2 of the School Education Law of Japan and have been recognized as possessing the necessary academic ability to receive education at the Graduate School of Human Development and Environment, Kobe University.
- (10) Applicants whom the Graduate School of Human Development and Environment of Kobe University has deemed via a separate enrollment eligibility screening process to possess academic ability equivalent to or higher than a university graduate and who will be 22 years of age by March 31, 2026.

II. Special entrance examination for working adults

Persons who have three or more years of working experience at the time of admission and fall under any of the following conditions. However, international students are not included.

Please note that persons who have eligibility for the special entrance examination for working adults may also apply for the general entrance examination.

- (1) Applicants who have graduated or will have graduated from a four-year program in Japan by March 31, 2026.
- (2) Applicants who have received a bachelor's degree under Article 104-7 of the School Education Law of Japan or will have received one by March 31, 2026.

- (3) Applicants who have completed at least 16 years of formal education overseas or will have completed it by March 31, 2026.
- (4) Applicants who have graduated with at least 16 years of formal education at an overseas school by completing the class subjects in a distance learning course while residing in Japan, or will have completed the course by March 31, 2026.
- (5) Applicants who have completed the course at foreign university in Japan, or will have completed the course by March 31, 2026 (limited to those courses whose graduates are considered to have completed 16 years of formal education in the foreign country). The school must be recognized as an educational institution by their home country's education system, and approved by the Minister of the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- (6) Applicants who have received a degree equivalent to a bachelor's degree by completing at least 3-year program at a foreign university or other foreign educational institution. The foreign university or other foreign educational institution must be accredited in terms of overall education and research activities by the respective foreign government or a person certified by the appropriate foreign governmental agency, or have been so designated by the Minister of the Japanese Ministry of Education, Culture, Sports, Science and Technology. The above mentioned 'at least 3-year program' can be completed: by taking class subjects offered by the respective foreign educational institutions in distance learning format while residing in Japan, and by graduating from an educational institution which is recognized by the home country's education system and specified in the previous item (5).
- (7) Applicants who have graduated from specialized training colleges course (limited to courses of at least four years of duration and of meeting the other standards specified by the Minister of the Japanese Ministry of Education, Culture, Sports, Science and Technology) that has been separately recognized by the Minister of the Japanese Ministry of Education, Culture, Sports, Science and Technology, or will have graduated from the course by March 31, 2026. - (8) Applicants who have been specially designated by the Minister of the Japanese Ministry of Education, Culture, Sports, Science and Technology (under the Ministry of Education Notification No. 5, 1953).
- (9) Applicants who have enrolled in Japanese graduate school under Article 102-2 of the School Education Law of Japan and have been recognized as possessing the necessary academic ability to receive education at the Graduate School of Human Development and Environment, Kobe University.
- (10) Applicants whom the Graduate School of Human Development and Environment of Kobe University has deemed via a separate enrollment eligibility screening process to possess academic ability equivalent to or higher than a university graduate and who will be 22 years of age by March 31, 2026.

III. Special entrance examination for international students

A person who does not have Japanese nationality who falls under any of the following items and is able to obtain the status of residence of "Student" after enrollment:

- (1) Applicants who have completed at least 16 years of formal education overseas or will have completed it by March 31, 2026.
- (2) Applicants who have graduated or will have graduated from a four-year program in Japan by March 31, 2026.
- (3) Applicants who have graduated with at least 16 years of formal education at an overseas school by completing the class subjects in a distance learning course while residing in Japan, or will have completed the course by March 31, 2026.
- (4) Applicants who have completed the course at foreign university in Japan, or will have completed the course by March 31, 2026 (limited to those courses whose graduates are considered to have completed 16 years of formal education in the foreign country). The school must be recognized as an educational institution by their home country's education system, and approved by the Minister of the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- (5) Applicants who have received a degree equivalent to a bachelor's degree by completing at least 3-year program at a foreign university or other foreign educational institution. The foreign university or other foreign educational institution must be accredited in terms of overall education and research activities by the respective foreign government or a person certified by the appropriate foreign governmental agency, or have been so designated by the Minister of the Japanese Ministry of Education, Culture, Sports, Science and Technology. The above mentioned 'at least 3-year program' can be completed: by taking class subjects offered by the respective foreign educational institutions in distance learning

- (7) Applicants who have enrolled in Japanese graduate school under Article 102-2 of the School Education Law of Japan and have been recognized as possessing the necessary academic ability to receive education at the Graduate School of Human Development and Environment, Kobe University.
- (8) Applicants whom the Graduate School of Human Development and Environment of Kobe University has deemed via a separate enrollment eligibility screening process to possess academic ability equivalent to or higher than a university graduate and who will be 22 years of age by March 31, 2026.

(Note) Screening for individual eligibility for admission (preliminary eligibility)

Persons must undergo a preliminary examination of eligibility for this Graduate School prior to application if the intention is to apply under the above mentioned general entrance examination eligibility (9) or (10), special entrance examination for working adults eligibility (9) or (10), or special entrance examination for international students eligibility (7) or (8).

Also, persons to whom the general entrance examination eligibility (10), the special entrance examination for working adults eligibility (10), or the special entrance examination for international students eligibility (8) apply refers to persons who do not have a university graduation qualification, such as persons who are graduates of junior colleges, technical colleges, specialized training colleges, or various other schools, persons who are graduates of a Japanese school of a foreign university, a school for foreign students, or other educational facilities (including expected graduates).

Those who wish to apply for the preliminary screening must send the following documents [1] through [7] by postal mail (registered express mail) to arrive between **Friday**, **June 20**, **2025 and Thursday**, **June 26**, 2025(Must arrive during this period).

- [1] Eligibility screening application (Enter your name and other information on the application form posted on the website and submit it.)
- [2] Curriculum Vitae (Use the Curriculum Vitae form posted on the website.)
- [3] Academic transcript and proof of graduation or completion (or expected graduation or completion) or certificate of leaving, prepared by the final school principal
- [4] A description (in any format) of the study history, practical experience, international activity experience, etc., of applicants who are considered to have academic ability equal to or greater than that of university graduates
 - Documents of any other past results of the applicant that are thought to be useful as a reference, such as books, papers, patents, utility models, or journal articles (Copies are accepted)
- [5] Research plan for this Graduate School (Use the research plan form posted on the web page.)
- [6] Envelope for notification of screening result (A standard-size envelope with the return address, name and zip code written and 410 year of stamps for express postage pasted on it)
- [7] Undergraduate academic transcript and certificate of leaving (Only for persons intending to apply under general entrance examination eligibility (9), special entrance examination for working adults eligibility (9), or special entrance examination for international students eligibility (7))
 - * The documents submitted for the screening will not be returned.
 - * The Graduate School will examine the eligibility based on the submitted documents, by comprehensively considering matters such as the specific contents of the study history, practical experience and international activity experience of the individual, and the research plan.
 - * Notification of the results of the screening will be sent to the individual by Friday, July 18, 2025 at the latest.
 - * Please do not send application documents or pay the examination fee before receiving notification of the result of the screening.

4. Application Period

22 July, 2025, Tuesday to 28 July, 2025, Monday 4:00 pm (Must arrive during this period)

Those who send applications by postal mail should send them by registered express mail and send them as soon as possible with consideration of the postal conditions.

Persons who bring the application themselves should bring it either between 9:00 am and 12:00 pm or between 1:00 pm and 4:00 pm on any day except Saturdays and Sundays during the above application period.

5. Application Procedure

Applicants should prepare the following documents and either bring them or send them by registered express mail.

Applicants who applied for the screening for individual eligibility for admission (preliminary eligibility) and received permission may omit the submission of the documents (1), (2) and (6) below. Also, depending on the examination category, it may be necessary to submit a research report or papers, etc., so refer to the Appended Table (page 9).

Only persons taking the Special entrance examination for international students of the Human Environmental Science are allowed to use the English Formats of Application Form, Curriculum Vitae, Research Plan, Admission slip and slip of identity verification.

7. Selection Method, Date and Venue of Examination

(1) Selection Method

The selection will be made based on comprehensive consideration of the results for the specialized subjects (written examinations (including presentations)) and oral examinations, the English test results submitted, and the academic transcript, etc., from the university of the applicant.

For the examination subjects and oral examinations, see Appended Tables I to II (pages 11 to 14).

(2) Date of Examination

Thursday, September 11, 2025 and Friday, September 12, 2025

However, depending on the situation of applications, the examinations may be implemented on one day only, on Thursday, September 11, 2025. Notification of the date and time of implementation will be given when the examination admission slips are sent.

For applicants for the Clinical Psychology Course examination category in the Department of Human Development, the results of the written tests and the English test results submitted will be used to select a group of applicants numbering around twice the Admission Capacity. Only these selected applicants will take the oral examination. The results of the selection based on the written examinations will be announced on the notice board concerning the entrance examinations (the notice board of the Graduate School of Human Development and Environment) at 11:00 am on the day of the oral examination.

If we determine that it is not possible to safely conduct the entrance examination in person due to the impact of novel coronavirus infections, we will postpone the examinations to the following dates.

Furthermore, if the examinations are postponed, the examinations will be conducted remotely using the online conference system Microsoft Teams. (Examinations will not be conducted in person.) If the examinations are conducted remotely, candidates will need a communication device (such as a personal computer or tablet PC) that is equipped with camera, speaker and microphone functions. Communication devices with telephone functions, such as smartphones, cannot be used because there is a risk of the examination being interrupted. In addition, if the entrance examinations are to be conducted remotely using Teams, we expect to conduct connection testing using the same environment as the examinations about one to two weeks before the date of examination.

In addition, applicants will be notified of the details of the entrance examination methods and other matters in the Information for Examinees and by email (sent to the e-mail address indicated in the application form).

10. Handling of Personal Information

- (1) Kobe University complies with legislation such as the "Act on the Protection of Personal Information" in using applicants' personal information, and handles it based on the "Guideline on the Control of Personal Information Held by Kobe University."

12. Long-term course student system

This is a system for persons who would have difficulty obtaining and completing the necessary credits within two years due to circumstances such as having an occupation. At the time of admission, such persons can apply to systematically obtain and complete credits during a period that is longer than two years. If the university approves this application, the system allows students to be enrolled at the university for more than two years, but with the payment of the tuition fee for two years.

The annual tuition fee becomes the total amount of tuition fee for two years divided by the number of years recognized for the student as a long-term course student. However, if the tuition fee is revised during the period of enrollment at the university, the new tuition fee will be applied from the time of the revision.

The circumstances such as having an occupation refers to persons who fall under any of the following, who would have difficulty studying within the standard term of study.

- (1) Persons who have an occupation and are working (including self-employed and temporary workers (but excluding one-off part-time jobs))
- (2) Persons with circumstances such as household affairs, child care, nursing care, etc.
- (3) Other persons for which it is deemed reasonable by the Dean of the Graduate School of Human Development and Environment

Please note that even if there are circumstances such as having an occupation, this system is only permitted under certain conditions.

Persons wishing to apply should consult with the person in charge in advance.

The deadline for the application procedures is Monday, February 10, 2025.

- 15. Preventive measures against measles, rubella, epidemic parotiditis, and chickenpox
- (1) Submission of a certificate demonstrating inoculation and an antibody test against measles and rubella:

Kobe University has implemented the *Measles and Rubella Registration Policy*, and all newly enrolled Kobe University students must submit <u>one of the following three certificates (1) (2) or (3)</u> to prevent a possible outbreak of measles and rubella on campus.

Please note that students admitted to the following schools are required to submit either ① or ③: School of Medicine (Faculty of Medicine and Faculty of Health Sciences), the Graduate School of Medicine, or the Graduate School of Health Sciences.

- ① A vaccination certificate to prove that you have received two doses each of the measles and rubella vaccine after turning one year old (recommended)
- ② A vaccination certificate to prove that you were inoculated with measles and rubella vaccines each within the last five years (since April 2021).
- ③ An antibody certificate to prove that you have sufficient antibody titer in your blood (refer to the chart next page) to prevent the development of measles and rubella, based on the results of an antibody test performed within the last five years (since April 2021)
- * For ① and ②, a combined vaccine against measles and rubella (e.g., MR vaccine) is permissible.
- * For ① and ②, the certificate must be issued by an accredited medical institution and state the <u>type</u> of vaccine and the date of inoculation.
- * If you have a history of measles or rubella, please submit 3 or receive a vaccination and submit 1 or 2.
- * For ③, the certificate must specify the measuring method and the measured values of antibody titer in your blood (refer to the next page), and it must satisfy the judging standard listed in the chart. A blood test report sheet itself can be accepted for submission.

If the antibody titer in your blood is insufficient, you must receive the necessary vaccination, and submit either ① or ②.

- * You may submit a combination of ①, ②, and ③ (e.g., ① for measles and ③ for rubella).
- * If your antibody titer level is below the threshold, yet you are unable to receive the vaccinations due to certain circumstances (such as illness or specific body conditions), please provide an official document (like a medical certificate) that explains the reason.

In addition to the measles and rubella certificate, successful applicants enrolling in the School of Medicine (the Faculty of Medicine and the Faculty of Health Sciences), the Graduate School of Medicine, and the Graduate School of Health Sciences, are also required to submit a certificate regarding epidemic parotiditis and chickenpox. A designated form for the certificate is available at the Academic Affairs Section.

The certificate must state that either you were inoculated against epidemic parotiditis and chickenpox (twice each after one year of age), or verify that you have sufficient antibody titer in your blood to prevent the development of epidemic parotiditis and chickenpox based on an antibody test performed within the last five years (since April 2020).

If the antibody titer in your blood is insufficient, you must receive the necessary vaccination (twice each), by the due date for the certificate submission. (The two vaccinations must be given at least 4 weeks apart.)

* If your antibody titer level is below the threshold, yet you are unable to receive the vaccinations due to certain circumstances (such as illness or specific body conditions), please provide an official document (like a medical certificate) that explains the reason.

 - Students of the Graduate School of Medicine should submit directly to the Medical Center for Student Health, Kusunoki Branch.
- Students of the Graduate School of Health Sciences should submit directly to the Physical and Mental Health Consultation Office (Myodani Campus).

- * Antibody testing is not required if the vaccination history meets the requirements or if additional vaccinations are given.
- * Make sure the above methods are followed when the antibody titer is measured in your blood.
- * The protective antibody value differs according to the measuring method used. Please note that the judging standards are higher than the usual standards used at medical institutions.

Students who wish to enter the School of Medicine (the Faculty of Medicine and the Faculty of Health Sciences), the Graduate School of Medicine, and the Graduate School of Health Sciences should note that they are required to have a higher level of protective antibodies against measles, as indicated in brackets.

* Before visiting a medical institution, please confirm in advance whether you can receive the necessary antibody tests and/or the vaccinations.

When you visit a doctor at a medical institution, make sure to present this document to obtain the necessary certificate(s). (In particular, when taking an antibody test, please ensure the measurement methods meet the above criteria.)

- * Points to consider when submitting a certificate:
 - (1) Please bring the original certificate along with one copy (A4 size).
 - ② If the certificate is written in a language other than Japanese or English, please attach a document showing the Japanese or English translation.
